- Be 18 years old or older ;
- Be physically fit to handle a dog with a weight over 75 pounds ;
- Not leave the dog alone for more than 4 hours ;
- Take part to the behavior sessions and health follow-ups;
- Bring the dog back for his evaluation at 1 year (For 1 week).

Please note that all appointments are held at Mira Sainte-Madeleine and that this is a commitment that can last from 12 to 18 months. The Mira Foundation reserves the right to withdraw a dog from a foster family at any time, if the established criterias are no longer met.
